- 7. I will be responsible for removing in a timely manner any debris resulting from construction.
- 8. I will be responsible for complying with and will comply with all applicable federal, state, and local laws, codes, regulations, and requirements in connection with this work, and I will obtain any necessary governmental permits and approvals for the work. I understand and agree that the Association, its Board of Directors, its agents, and the committee have no responsibility with respect to such compliance, and that the Board of Directors or its designated committee's approval of this request shall not be understood as making any representation or warranty that the plans, specifications, or work comply with any law, code, regulation, or governmental requirement.
- 9. I agree that any misrepresentations of any items in this request, either oral or written, may void any approval by the committee.
- 10. I understand that a decision by the committee is not final and that the Board of Directors may reverse or modify a decision by the committee upon the written application of any owner made to the Board of Directors within 10 days after the committee makes its decision.

1. An applicant desiring to install a washer and dryer in the unit must supply, with this application, architectural drawings to be submitted to the County for an installation permit. building, whether encased in wood or any other type of chase. All plumbing must be installed within the existing exterior walls, so as not to make any change to the appearance of the building. The applicant is responsible to include the removal, reinstallation, and necessary painting of siding by the contractor.
